## Firearms Licensing

You can apply for a Firearms I.D. (FID) card or Class A or B License to Carry Firearms (LTC) at the Ashburnham Police Department. They will only be available to process at designated times. Therefore, please contact Kristin Mathieu, Administrative Assistant at 978-827-4413 or via email to schedule a time to process your LTC application.

### What You Will Need:

1. A completed application. All information on the application must be accurate, so please read all questions carefully and answer them completely and accurately.
2. Fees can only be paid by Check or Money Order. Please make checks payable to the Town of Ashburnham. Cash will not be accepted.
3. For first time LTC requests, a copy of a certificate of completion of a State approved basic firearms safety course or a certificate of completion of a hunter education course issued by the Massachusetts Division of Fisheries and Wildlife is required.
4. Proof of residency (Driver's license or Massachusetts I.D.)
5. For renewals you must have your current LTC.

Once your application is processed and approved, you will be contacted by this department to pickup your LTC.

## The license fees are as follows:

- License To Carry Firearms Identification Card: \$100.00 - 6 Years  
No Fee Charged for Applicants 70 Years of Age or Older
- License to Sell, Rent or Lease Firearms \$100.00 - 6 Years
- License to be in business as a Gunsmith: \$100.00 per year  
No Fee Charged if Applicant has License to Sell, Rent or Lease
- License To Sell Ammunition: \$100.00 per year
- Firearms I.D. Card: Restricted to Chemical Propellant or Pepper Spray:  
\$25.00  
No Fee Charged for renewal Applicant
- License to Possess Machine Guns - 6 Years  
No Fee Charged for Renewal Applicants 70 Years of Age or Older
- Permit To Purchase Firearms: \$100.00

Effective December 1, 2005

Chapter 140, Sections 122, 122b, 129b, 131, 131a, 131f, and 131h have been amended to change the fee schedule for Massachusetts Firearms Licenses.

## To Receive a Firearms Identification Card (FID)

- You Must be 18 years of age or older, or 15 to 18 years old with parental consent to apply for an FID Card.
- A restricted FID is available solely for the possession of mace or pepper spray.
- The current FID card will be valid for 6 years and permits the possession and carrying of non-large capacity rifles and shotguns.

## To Receive a License to Carry Firearms (LTC)

Class A License – permits the purchase, possession and carrying of large-capacity handguns, rifles, shotguns and feeding devices.

Class B License – permits the purchase, possession and carrying of non-large capacity handguns and large-capacity rifles and shotguns.

**For both Class A LTC and Class B LTC**

- New applicants must be 21 years of age or older
- Your current LTC will be valid until its stated expiration date
- The new Class A and Class B LTC's are valid for 6 years
